Sub: A. To register case, Threat, Criminal Intimidation, illegal confinement, public detention, and also Prevention of Corruption Act 1988, on Investigation Officer, and his Senior police officer, who has abused the legal process, in connivance with culprits.

B. Take cognizance of serious offence of IO and his senior for making false statements in the FIR(station diary).

Respected Sir/Madam,

1. Mr Mukesh Thakur is Vice President, of our NGO Ludhiana society for fast justice; and also Vice President of Judge Advocate Pedit Organization-(herein referred to as JAPO). Mr Mukesh Thakur and Lucky Alias Jai Hind have exposed the brother of [REDACTED] Kaur, Amritpal Singh alias Vicky, and also Food inspector Sukhdev Singh.
2. I the undersigned state that, [REDACTED] Kaur has filed a false complaint in connivance with the above mentioned police officials, alleging complaint of grievous physical assault/injury/ to herself by Mr Mukesh Thakur and Lucky Alias Jaihind. The medico legal report is given by Civil Hospital, post an hour of the alleged incident, shows no injury or blood or harm to [REDACTED] Kaur, which clearly proves the false statement made by her to the Police, stating that she was stabbed by sharp weapon.

The duty officer/IO Ajit Singh at Division No. 1 (Kotwali) police station summoned both the accused at 2.00 pm on 21/6/2017, and charged them with 353/354/307 IPC, and after undersigned intervened, Mukesh Thakur and Lucky, were charged with IPC 107/151, and were kept behind the bars entire night, with gross abuse of law and power with mala fide intentions. This is also against Whistle Blowers Protection Act.
4. Mukesh Thakur and Lucky alias Jai Hind, both had not been even in Vicinity of [REDACTED] Kaur, and same can be ascertained with CCTV footage/Mobile tower /CDR of the Accused and Victims in the matter, hence we request to **CALL FOR ON HIGH PRIORITY AND IN INTEREST OF JUSTICE:-**

Following evidence be collected for unveiling truth :

- a) **Entire CCTV footage of video recordings of the smart city project, Ludhiana**
 - b) **CCTV footage of all the cameras from both sides of the flyover from Rekhi Cinema/Bank of India Zonal Branch GT Road to Ghanta Ghar, Old Court Road to Old Court Session Chowk, and towards Police Commissioner Ludhiana Residence**
 - c) **Camera Installed at Fountain Chowk and Kailash Cinema, entire CCTV recordings for the mentioned places in above and this point from 11.25 am to 12.25 pm on 21/06/2017.**
 - d) **Mukesh Thakur Mobile Number 81467-61055, and Lucky Mobile Number 73554-27270, [REDACTED] Kaur Mobile Number [REDACTED].**
 - e) **Nauhrias Multi Specialty Hospital, HIG - 452, Jamalpur Colony, Ludhiana CCTV footage of the alleged day between 11.00 am to 1.00 pm.**
5. Mukesh Thakur was in the office from 9.30am and Lucky /Jai hind was at Nauhrias Multi Specialty Hospital, HIG -452, Jamalpur Colony, Ludhiana, where his mother was getting operated, and the same can be recovered from the CCTV footage of the alleged day between 11.00am to 1.00pm. His employer can prove this.

And interim kindly make sure the details of the recordings are preserved till final disposal of both the complaint and case is registered against the corrupted and the real Accused who are the Police official, [REDACTED] Kaur, and her Aides.
7. **The Onus of furnishing the above details and video recordings along with the call CDR, lies with you and other government authorities, and in case of same being denied, All the people involved and responsible for issuing the same will be held liable and responsible for destruction of evidence and criminal conspiracy**, due to which gross abuse of process of law and miscarriage of justice has happened to Mr Mukesh Thakur and Lucky Alias Jai Hind. It is also case if screening evidence.
8. Kindly have the same expedited on high priority basis, and Any further delay will be gross Contempt of the Court and Legal Process in violation of principles of natural Justice, which please note and the undersigned reserves right to file a Criminal Complaint for cost and damages for mental, physical harassment along with criminal defamation as to your risk, cost and consequences which please note.

Kindly take necessary step to have impartial and fair trial TO Mr. Mukesh Thakur and Lucky alias Jai Hind at the earliest without delay.
