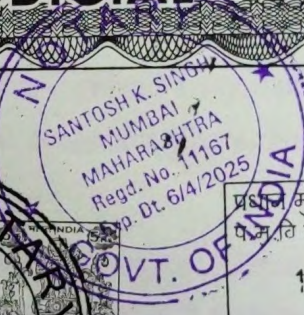

I say that since August 2020, (1) Mr. Akhtar Yusuf Ansari @ Bablu, (2) Jalil Mulla, (3) Anwar Khan @ Annu, (4) Salim Qureshi (5) Firoz Khan @ Boss, (6) Suleman Khairani, (7) Sharik Ansari, & Other used to follow and pressurizing me to file false complaint of Rape against Mr. Nasir Manihar, Zakir Manihar, Badruddin Manihar, and Ramjan Manihar. I say that the above person have offered me Rupees Fifty Thousand and a flat in SRA for making false complaint against member of Manihar family. I say that at first the above said person met me in the same area of my residence and made request of filling Rape case of started above then second and third time they started to threaten me by filling me that they will implicate myself in false case, if I did not file rape case against Manihar family. I say that Akhtar Yusuf Ansari said "If you did not file rape case against Manihar family then we will take you to Shailam Mahadev Koli and PI Kantyalal Shinde of BKC Police Station and implicate you in cheating and 307 case. (I say that I have taken video evidence of this incident) I say that he also said "Tumko Tadipar Karenge aur Jail me dal denge aur Bharat Nagar Ka Tere Maa-Baap ka ghar khali karva denge".

I say that after this incident above said person Akhtar Ansari and others used to follow me and restraining my path and abusing me paying "Chinnal, Randi and other bad words" and many witnesses are there who have seen Akhtar and others while abusing me on several occasion in our area.

I say that Mr. Akhtar and other then started harass my mother and father by visiting our home and said "Ye Bhade Ka Ghar Tumko Khali Karwane lagayegee, Tumhari Ladki ko bolo ham log jaisa bol rahe hai vaisa karne ke liye"

I say that I have filed DV Case against my husband which is pending in Bandra Court. I say that Mr. Akhtar and other then contacted to my husband with the same request of filling false rape case on Manihar family. I say that then my husband also started to pressurizing me to do as stated by Mr. Akhtar. I say that my husband have taken some money from Mr. Akhtar for pressuring me. I say that on my refusal my husband have filed false N.C. against me and Mr. Akhtar started to defame me and stated that they have filed N.C. against me and soon I will be TADIPAR.

I say that on August 2020 at about 1.00 p.m. I am unable to remember exact date, time, Akhtar Yusuf Ansari, Jalil Shaikh, Sharik Ansari followed me and restarted my way of forcefully took me to Gulshan Nursery 11 no. plot and snatched my mobile (Akhtar Ansari) and forcefully pushed me four wheeler and took me to Kandivali (W) crime branch office and present me before one officer and Akhtar said to that officer, "Manihar family ne Pathar Nagar SRA Project me illegal kam ki puri vat lagayi hai, is ladki ke name se Manihar family per rape case banana hai, apko pachhis lakh dete hai, Manihar family ka encounter kar do". Akhtar Ansari gave photo to police officer of Badruddin & Ramzan. Then Akhtar brought me out of the cabin of that office and other were talking with that officer. Then they brought me back to the area, Bharat Nagar, and while coming also threatening me. I say that I totally refuse to file rape case on Manihar family.

I say that I have video and audio recording of some incidents mentioned above and ready to give you CD on the same. I say that I want to register FIR against (1) Mr. Akhtar Yusuf Ansari (2) Jalil Shaikh (3) Sharik Ansari.
