| <p>Spreading false news on manihar family by The times of India That manihar family has registered under 45 cases and showing them as a history sheeter and criminal.</p> <p>1. Police are showing 45 cases but on manihar family, But according to the fact and above given chart 11 cases are showing on 8 member of manihar family including female of manihar family and 4 cases are showing wrong.</p> <p>2. Earlier to the year 2014, 12-16 years prior 2 FIR were shown by police, when manihar family request to transfer the cases to CBI for justice and started hunger strike that time, Police machinery were forcefully destructed the hunger strike with showing 12-16 earlier case.</p> <p>3. Police machinery had misused their power to falsely implicated the whole family as police is showing 14 cases on all family members, it is clear show in this 3 FIR (162/14, 278/16 and 279/16) that whole family has been implicated falsely just to harass. But no action were taken on police machinery for registering the false case against manihar family.</p> <p>4. In FIR bearing no. 255/2019, In this there was CCTV footage as crucial evidence and told to seize the DVR, but it was never came on record because in that the matter clearly shows What happened on the spot.</p> | | | | | | | | <p>5. In the matter of 420 FIR bearing no. 69/2020 Mr Badruddin had gone for complaining about the scam with evidence but police machinery lodge the false FIR against Mr. Badruddin to pressure and to destroy all the evidence against the goons and police.</p> <p>6. FIR bearing no.176/2020 was false When manihar family shown the CCTV footage to the police then after seeing The CCTV footage police registered the FIR bearing no. 177/2020.</p> <p>7. According to the statement of I.O. it clearly shows that the false FIR bearing no.176/2020 and FIR bearing no. 180/2020, 14 innocent people were falsely implicated and Informant Mr. Shariq and his goons robbed the DVR to destroy the crucial evidence but no FIR was registered against the informant and no action was taken by BKC Police.</p> <p>8.
